February 2013.

Firstly may I thank you for your cooperation in arranging your appropriate areas for this years T.20 Competition. Regrettably there will be no entry from North Devon this year.

The DCL, therefore, have decided to rearrange the regions as shown below.

There will still be FOUR REGIONS and therefore two semi final matches and one final on the Finals day

**THE EAST** area will be organised by Tony McIntyre. Tel: 01884255836

**THE SOUTH** area will be organised by Geoff Coish. Tel: 07833193477

(This area has been split into two sections due to the potential travelling problems. Jim parker has kindly agreed to run the 'Torbay section with four clubs. There will be a play off between the Torbay and Teignbridge area winners on 17<sup>th</sup> July.

**The MID DEVON** area will be organised by Andy Jarman Tel: 01822 615864

**The WEST** area will be organised by Jon Sparkes. Tel: 07990858637

The appropriate area organisers will contact the Clubs concerned and advise them of the fixtures. The Torbay area competition will merge with the Teignbridge (SOUTH) area.

The Devon Cricket League will be organising the County area finals as in previous years. The Semi-Finals and Finals will take place at **Exeter Cricket Club** on Sunday 28<sup>th</sup> July 2013.

The ECB Regional Finals being brought forward to 11<sup>th</sup> August at a venue to be decided.

It is therefore essential that we know the County area winners by no later that 19<sup>th</sup> July.

If you not already done so please let me know the names of the Cricket Clubs that have entered each area competition and also the date that your area final will be determined. We have recently received dispensation from ECB that non Premier Division Clubs and those affiliated to the DCB will be permitted to enter the final stages of the Competition.

As in previous years all the Clubs in the County taking part will be registered with ECB this will obtain funding towards the running of the area competition together with our sponsor Messrs Ivor Dewdney.

I attach a further copy of the current rules of the DCL T.20 Competition, they are also available on line and will be contained within the 2013 DCL Handbook. It would be good if all area competitions use the same rules in qualifying.

I wish to point out that this year we will again be using 'PINK' Tiflex Balls. These are, the balls recommended by ECB and will be used in all the ECB T.20 Competitions. It is our wish that the regional competitions use the same ball, if possible; the DCL are able to provide the balls. The DCL will provide the balls for the area finals and the finals day.

Remember that the DCL will only become involved in the Competition in the final stages, however if you wish to raise any issues then please contact me.
